### Information on personal data processing

The company CRH (Slovensko) a.s. as a data controller hereby provides to persons entering its premises (hereinafter only as "data subject") in terms of § 19 of Act no. 18/2018 Coll on Protection of Personal Data (hereinafter only as "Act") the following information:

Processed personal data: personal data provided by the data subject in the questionnaire or self declaration incl. special category of personal data concerning health

Purpose of processing: processing is necessary for the purposes of carrying out the obligations and exercising specific rights of the controller or of the data subject in the field of employment and social security and social protection law in so far as it is authorised by Union or Member State law or a collective agreement providing for appropriate safeguards for the fundamental rights and the interests of the data subject (§16 section 2 letter b) of the Act) legitimate interests of the data controller

Legal basis for processing: § 13 section 1 letter c) processing is necessary for compliance with a legal obligation to which the controller is subject (§147 of the Labour Code, §6(1)(a) and §6 (7) of the Act on OH&S) § 13 section 1 letter d) processing is necessary in order to protect the vital interests of the data subject or of another natural person § 13 section 1 letter f) legitimate interests of the data controller

Legitimate interests of the data controller: creation of database of persons authorised to enter the premises of the data controller as a part of measures to prevent the emergence and spread of the communicable disease COVID-19 measures to prevent the emergence and spread of communicable disease COVID-19 according to Act no. 355/2007 Coll. on the protection, promotion and development of public health implementation of general principles of prevention in the interest of ensuring safety and protection of health at work and fulfillment of obligations pursuant to Act No. 124/2006 Coll. on OH&S

Period of storage/criteria for its definition: duration of the purpose, calendar year in the registry of the organisational unit, storage period in terms of registry rules and registry plan, archive in the case of permanent documentary value

Rights of the data subject: right to access personal data, right of rectification, right to deletion, right to restriction of processing, right to object to processing, right to data transferability, right to lodge a complaint and commence proceedings on the protection of personal data, right to withdraw consent to processing of personal data any time, whereas the withdrawal from consent does not affect the lawfulness of personal data processing based on consent before its withdrawal

Provision of personal data: is a contractual requirement of the data controller and in case of failure to provide the data the data controller is entitled not to allow the data subject to enter its premises

Categories of recipients: a company represented by the data subject, companies of the CRH Group in the Slovak Republic (in particular TransPlus (Slovensko) s.r.o., ecorec Slovensko s.r.o.), Baunit, spol. sr.o. No automated individual decision making or profiling is carried out.
